Subject: Transfer of Generation Licence Application – Batchelor Solar Farm Pty Ltd to BSF Co Pty Ltd (ACN 635 853 137) as trustee for the BSF Unit Trust

Batchelor Solar Farm Pty Ltd (**BSF**) on behalf of BSF Co Pty Ltd (ACN 635 853 137) as trustee for the BSF Unit Trust (**BSF Co**) hereby applies to the Utilities Commission of the Northern Territory (**Utilities Commission**) for the transfer of the BSF Generation Licence dated 1 October 2018 to BSF Co in accordance with Section 33 of the *Electricity Reform Act*.

BSF Co has purchased the BSF grid connected solar photovoltaic project assets from BSF and is currently constructing the project known as the **Batchelor 2 Solar Farm**. Further, BSF has entered into a life-of-plant Power Purchase Agreement for one hundred percent (100%) of the electricity output of the Batchelor 2 Solar Farm with the Northern Territory licenced electricity retailer Rimfire Energy Pty Ltd (**Rimfire Energy**).

Please note that due to confidentiality BSF has not been provided with, and therefore has not reviewed, some annexures referred to in the attached *Application to transfer of a Standard Generation Licence* that have been submitted by BSF Co directly to the Utilities Commission.

BSF notes the view of the Utilities Commission regarding adopting a non-prescriptive form for licence applications. BSF Co has confirmed to us that the detailed information contained in the **attached** *Application to Transfer of a Standard Generation Licence* is provided based upon the specific information requirements set out in the current version of the Utilities Commission's Licencing Manual, including the following major subject areas (amongst others):

- Legal Identity;
- Contact Details;
- Licence Type;
- Licensee Details;
- Nature of Industry Participation;
- Technical Capacity; and
- Financial Viability.

We also note that we have reviewed the information contained in the current version of the Licence Fees Schedule and request that an invoice for the licence transfer application fee be sent to BSF as soon as practicable.

BSF Co and MC Power are undertaking a long-term and significant investment in the Northern Territory electricity industry via the development and operation of the Batchelor 2 Solar Farm and the Hudson Creek Power Plant. These investments will be managed by Merricks Capital Pty Ltd to provide MC Power's investors with an attractive, stable and long-term return facilitated via life of asset PPAs with Rimfire Energy. BSF Co has entered into an EPC Contract with BSR for the design, construction, commissioning, testing and physical operations and performance of the Batchelor 2 Solar Farm. BE Power acts in the capacity as the owners engineer and project director for delivery of the EPC contract on behalf of BSF Co.

BE Power is currently undertaking the Operational Readiness Planning for the Batchelor 2 Solar Farm including the preparation of a detailed SMMP specific to the project.
