ELECTRICITY PRICING ORDER

I, SYDNEY JAMES STIRLING, the Treasurer:

- (a) pursuant to section 44(1)(a) and (1)(b) of the *Electricity Reform Act* and with reference to section 43 of the *Interpretation Act*, revoke the electricity pricing order signed on 29 March that took effect on 1 April 2005; and
- (b) pursuant to section 44(1)(a) and (1)(b) of the *Electricity Reform Act*, issue the electricity pricing order specified in the Schedule, to take effect on 1 July 2006 and remain in force to 30 June 2007.

ORDER

1. **Definitions**

In this Order:

- "caravan park resident customer" means a non-contestable customer that is on-supplied electricity by the proprietor of a caravan park (who is also a non-contestable customer) that is supplied electricity by the Power and Water Corporation;
- "commercial demand tariff customer" means a non-contestable customer who purchases electricity primarily for reasons other than for domestic use, and who consumes, or is likely to consume, more than 160 000 kWh per annum, and who elects to pay the commercial – demand tariff (as specified in Tables 1 and 2) for a period of not less than 12 months;
- "commercial standard tariff customer" means a non-contestable customer who purchases electricity primarily for reasons other than for domestic use and who does not elect to pay the commercial – demand tariff or the commercial – time of use tariff;
- "commercial time of use tariff customer" means a non-contestable customer who purchases electricity primarily for reasons other than for domestic use and who elects to pay the commercial – time of use tariff (as specified in Tables 1 and 3) for a period of not less than 12 months;
- "domestic pre-payment meter tariff customer" means a non-contestable customer who purchases electricity primarily for domestic use, supplied through a pre-payment meter;
- "domestic standard tariff customer" means a non-contestable customer who purchases electricity primarily for domestic use and who does not elect to pay the domestic – time of use tariff and who does not purchase electricity through a pre-payment meter;
- "domestic time of use tariff customer" means a non-contestable customer who purchases electricity primarily for domestic use, and who consumes, or is likely to consume, more than 16 000 kWh per annum, and elects to pay the domestic time of

use tariff (as specified in Tables 1 and 3) for a period of not less than 12 months;

"domestic use" means electricity used primarily for domestic purposes and not for use by government, commercial or not-for-profit organisations;

"kWh" means kilowatt hours;

- "kVA" means kilovolt amps;
- "non-metered installation customer" means a customer who purchases electricity for the type of installation as set out in Tables 4 and 5;
- "non-contestable customer" means an electricity customer who has not been granted a contestable customer certificate under the *Electricity Reform (Administration) Regulations* and whose annual electricity consumption for a given customer site does not exceed the minimum amount for a contestable customer as determined by the Schedule to those Regulations;

"related services" means:

- (a) services ancillary to the provision of electricity, if the Power and Water Corporation has an effective monopoly in the provision of the ancillary services; and
- (b) services ancillary to the ownership or operation of the infrastructure associated with the provision of electricity;
- "retail prices" means final GST inclusive prices for electricity sold to non-contestable customers by the Power and Water Corporation, in accordance with its retail licence.

2. Application of Order

(1) This Order only applies in relation to retail prices for electricity and related services supplied to non-contestable customers by the Power and Water Corporation.

(2) A price to which this Order applies is to comply with a restriction on pricing specified in directions or notifications issued in accordance with sections 28, 29 and 30 of the *Government Owned Corporations Act*.

3. Retail Electricity Prices

(1) The retail prices for electricity under this Order are to distinguish between the following non-contestable customer groups:

- (a) commercial standard tariff customer;
- (b) commercial demand tariff customer;
- (c) commercial time of use tariff customer;
- (d) caravan park resident customer;
- (e) non-metered installation customer;
- (f) domestic pre-payment meter tariff customer;
- (g) domestic standard tariff customer;
- (h) domestic time of use tariff customer,

in accordance with Tables 1 to 5 below.

(2) Prices for retail electricity for all non-contestable customer groups referred to in subclause (1) may only consist of:

- (a) for all customer groups except for domestic pre-payment meter tariff customers, non-metered installation customers, and caravan park resident customers – fixed daily charges that do not exceed the amounts detailed in Table 1; and
- (b) for commercial demand tariff customers peak and off-peak energy usage charges and peak and off-peak demand charges that do not exceed the amounts detailed in Table 2; and
- (c) for all customer groups except non-metered installation and commercial demand tariff customers usage charges that do not exceed the amounts detailed in Table 3; and
- (d) for non-metered installation customers charges per type of installation that do not exceed the amounts detailed in Tables 4 and 5.

4. Prices for Related Services

Prices for related services must be no more than a fair and reasonable amount taking into consideration the costs of providing the service in an efficient manner.

5. Role of Utilities Commission

The Utilities Commission must:

- (a) monitor compliance with this Order; and
- (b) enforce this Order in accordance with section 23 of the *Utilities Commission Act* in the same manner as if it were a determination under that Act; and
- (c) investigate any complaints made to the Utilities Commission by non-contestable customers that prices to which this Order applies do not comply with this Order.
